#### Approval of Minutes

The minutes from the Mar. 28, 2022 meeting were approved (4-0).

#### New Business: Bob Bonsall resignation

Bob informed us that he was resigning from the WTC for personal reasons, effective immediately. This news was greeted with much sadness. Bob is a founding member of the WTC, and one of its driving forces. Someone will need to take over his stewardship of the Commemorative Tree Program, as well as the Commemorative Tree data base (in Excel) that he developed and maintains. That database, plus the new Commemorative Tree pamphlet that he just put together, is available on the WTC google account.

- ▶ Designation of a person (or persons) to take on Bob's responsibilities was tabled.
- ▶ Bob will still take care of ordering the plaques for this year's batch of new trees.
- ▶ His resignation was accepted (4-0), with great regret. We'll miss you Bob!

#### Marigold Festival 2022 – Sat. May 14

We have a non-profit (free) booth. The plan:

- ▶ Lea will deliver table, chairs, tent and GFC material on Fri evening (5/13) between 5:00 and 8:00 PM. She could use some help.

Things to give out include the new Commemorative Tree Program pamphlet (thanks again Bob!), WTC membership applications, and GFC swag.

- ▶ Tina will talk to Wendy at City Hall about printing the pamphlet and the sign for our booth.

In addition, we have some educational posters that Holly made a few years back that describe the benefits of various trees. These can be hung on the relevant trees around Pittard Park.

- ▶ Brian will deliver those posters to Marilyn for updating/upgrading if necessary. ▶ Marilyn & Tina will hang them around the park on Fri.

### Workday Sat. 4/23/22 (information item)

This went well – the weather was great and we had about 6 participants total, including Brian, Bob, Tina, Marilyn (with Yonah and Wayah), Kathy, and Bruce. Tina, Bob, and Lea picked up mulch from the GFC on Fri, and on Sat. Bob brought some homemade goodies and Brian brought coffee. We weeded and mulched 13 or 14 trees, from about 8:00 – 10:00 AM.

### Gazette Entry

### Stem Guards

Bob had intended to talk to the City about purchasing some, to protect young commemorative trees from weed whacking. But if trees are mulched, they aren't necessary. Along with our work-day mulching, Tom seems to be mulching additional trees. We agreed to wait and see about the need for stem guards.

### City Arborist

Lea spoke with Susan Russell (city arborist for Jefferson) about possibly working as the Winterville city arborist. Susan is interested. Lea emailed the Mayor about this, but as of the meeting time, she hadn't heard anything back. There was a consensus that filling the city arborist position is critical for the WTC to function effectively, especially with regard to preserving the City's canopy. ▶ A motion to recommend Susan Russell for the position passed unanimously.

### City Tree inventory

Holly's students will enter the Commemorative Trees into an i-Tree Eco platform for a half a day on Mon. May 23. The students will make a presentation to the WTC, hopefully at our June meeting. The data the students collect will serve as the starting point for a citywide tree inventory. This summer, Lea and a GFC intern will add to the inventory.

### Georgia Tree Council Meeting November 2-3

### Fall Event

It was proposed that we could sponsor another workday in the fall, to honor commemorative tree sponsors. In addition to working on the trees, we could host a "tree product potluck." This would be a nice way to acknowledge tree sponsors and let them know that we value their trees.

- ▶ The motion to plan to do this in Sept. or Oct. of this year passed 4-0.
